Overview

This year's Special Session for PHLIP Physician Risk Officers & Risk Managers will begin with a discussion of the top-three practice assessment takeaways, along with mitigation strategies derived from members' best practices. Amy Uldrick, MSN, RN, CPHRM, CEN will share overall scores for the members as well as a side-by-side comparison of reassessment scores and findings.

Also presented will be a case study illustrating common issues among physician practices. We will look ahead at the plan for completion of physician practice assessments, reassessment strategies, and focused educational efforts.

Strides in technology such as smart phone medical applications, social media, and telemedicine are changing the landscape of medicine, opening up significant privacy concerns and liability issues that most healthcare providers have not anticipated. Tad Eckenrode, Esq. will highlight numerous discovery issues that can devastate an unprepared hospital or provider.

A discussion of diagnostic misadventure through cognitive bias, preconception, and failure to assess both the patient and situation will be led by Laurie Drill-Mellum, MD, MPH. She will share mitigation strategies for diagnostic and cognitive bias as ways to improve the diagnostic process and resulting patient outcomes.
